\*\* The Award Amount for Private and Proprietary schools is computed each year based upon the prior year's actual award payments to students attending similar public institutions.

\*\*\* The TOPS Award Payment for TOPS eligible students enrolled in a graduate/professional program is limited to the full tuition charged by a school for enrollment in the respective graduate program or the maximum TOPS Award amount listed here, whichever is less.

**Assumptions:**

- 1) **Estimated** Winter/Spring pro-rata amounts will be revised once actual billing numbers for Fall are obtained. The re-calculated pro-rata amounts will be available by November 1st. Actual amounts payable for Winter/Spring are subject to appropriation and funding received.
- 2) These estimates factor in GRAD Act Tuition increases and assume full Tobacco Stat Ded Funding of \$60,261,750.
- 3) TOPS for Summer School will only be funded if there are sufficient funds remaining.
- 4) Academic stipends for Performance and Honors are reduced at the same pro-rata rate as TOPS tuition.
- 5) The \$600 limit per year for the TOPS Tech Early Start program is not reduced; National Guard stipends are not reduced.
